Dear Singer or Parents:

Fairfax Choral Society (FCS) wants every qualified singer to join regardless of finances. With this in mind, FCS is able to provide partial assistance for dues and tuition based on financial need to a limited number of singers. The FCS Board will review and approve applications, and the FCS office will communicate decisions via a contract payment schedule for the remainder of the dues or tuition and required service hours. The singer or family contribution must be fully paid per the contract as soon as decisions are announced at the beginning of the season, after which the scholarship will cover the balance. Singers joining at other times of the year may apply within two weeks of their acceptance. **All assistance requires an annual application in writing with this form, one for each singer. There are no automatic renewals.**
